

Important Information Regarding: Thailand Civil Unrest

Advice 5 – Updated 17th of May 2010

Applies for all Travelsure products

The following advice relates to policies issued before the 23rd April 2010.

The Ministry of Foreign Affairs & Trade have upgraded their travel advice to Thailand. Please refer to www.safetravel.govt.nz. MFAT have stated (in part):

There is high risk to your security in Thailand due to the uncertain political situation, civil unrest and threat from terrorism and we advise against all tourist and other non-essential travel. New Zealanders currently in Thailand with concerns for their safety are advised to consider departing. Suvarnabhumi International Airport on the outskirts of Bangkok is operating normally.

FOR CUSTOMERS TRAVELLING PRIOR TO THE 31st of MAY 2010

ADDITIONAL ACCOMMODATION AND TRANSPORT EXPENSES

In the event your travel arrangements are directly affected by civil unrest, there is provision to claim reasonable additional accommodation and transport expenses. You must however take all reasonable steps to minimise your claim and keep itemised receipts for additional accommodation and transport expenses.

AMENDMENT OR CANCELLATION COSTS

FOR CUSTOMERS WHO HAVE NOT YET COMMENCED THEIR JOURNEY

If you are travelling to Bangkok prior to the 31th of May 2010 there is provision to claim for amendment or cancellation costs (whichever is less) for the part of your trip which involves travel in Bangkok. There is no provision to claim if you are only transiting in Bangkok.

You should contact your travel agent or travel provider regarding the best option for you in altering your trip. You must take all reasonable steps to minimise your claim and keep documentation showing what your original planned pre-paid arrangements were, along with receipts and documentation showing what your new arrangements are.

No cover will be provided for the utilised portion of prepaid travel arrangements. If you are claiming additional accommodation or transport expenses there is no provision to also claim for the cancellation cost of pre-paid travel arrangements for the same period. The policy also excludes cover for loss of enjoyment.

FOR CUSTOMERS TRAVELLING ON OR AFTER THE 31st of MAY 2010

It would be premature at this stage to determine whether the civil unrest in Thailand will continue beyond the 31st of May 2010. As such we don't recommend you cancel or amend your trip at this stage. We will update our advice regularly and you should check our website www.travelsure.co.nz for the latest advice every 24 hours.

For Annual Multi-trip policies issued prior to the 23rd of April 2010 the general advice below relates to when the travel bookings are made.

POLICIES ISSUED ON OR AFTER THE 23rd OF APRIL 2010.

The Amendment or Cancellation section of the Travelsure policy only provides cover for unforeseen circumstances.

The Ministry of Foreign Affairs & Trade upgraded their travel advice to Thailand on the 23rd April 2010 and the civil unrest in Bangkok has been publicised in the media since the 23rd April 2010. We therefore consider this event was not "unforeseen" for policies purchased on or after the 23rd April 2010. Travelsure policies will therefore not respond to claims for amendment or cancellation for policies purchased on or after the 23rd April 2010.

IMPORTANT - GENERAL ADVICE

This information must be read in conjunction with the Travelsure Policy Wording as certain restrictions apply.

All Travelsure policies exclude claims arising as a result of war, invasion, act of foreign enemy, hostilities (whether war be declared or not), civil war, rebellion, revolution, insurrection or military or usurped power.

If the situation in Thailand continues to deteriorate and Travelsure determines in the future that the situation in Thailand falls under any policy exclusion then that exclusion will apply to all policies issued on or after 27th April 2010. In respect of policies issued before 27th April 2010 the exclusion shall apply to all travels commencing on or after 1st May.
