

Important Information Regarding: Civil Unrest in Cairo, Egypt

Update 6: Issued: 1st March 2011

Applies for all Travelsure Ltd Policies

The following advice relates to policies issued on or before the 31st January 2011.

There is high risk to your security in Egypt due to the unpredictable security situation and we advise against all tourist and other non-essential travel.

Since 25 January 2011, violent protests and civil unrest have occurred in many parts of the country. Since ex-President Mubarak's resignation on 11 February the unrest has eased but the situation remains unpredictable. Strikes and protests continue to occur in towns and cities across Egypt and further unrest and violence cannot be ruled out. A curfew is currently in place between midnight and 6am.

FOR CUSTOMERS TRAVELLING ON OR PRIOR TO THE 28th of FEBRUARY 2011

ADDITIONAL ACCOMMODATION AND TRANSPORT EXPENSES

In the event your travel arrangements are directly affected by civil unrest, there is provision to claim reasonable additional accommodation and transport expenses incurred on your journey. You must however take all reasonable steps to minimise your claim and keep itemised receipts for additional accommodation and transport expenses.

AMENDMENT OR CANCELLATION COSTS FOR CUSTOMERS WHO HAVE NOT YET COMMENCED THEIR JOURNEY

In the event your travel arrangements are directly affected by civil unrest, there is provision to claim amendment or cancellation expenses.

In such an event you should contact your travel agent or travel provider regarding the best option for you in altering your trip. You must take all reasonable steps to minimise your claim and keep documentation showing what your original planned pre-paid arrangements were, along with receipts and documentation showing what your new arrangements are. The policy provides cover for amendment or cancellation (whichever is less).

No cover will be provided for the utilised portion of prepaid travel arrangements. If you are claiming additional accommodation or transport expenses there is no provision to also claim for the cancellation cost of pre-paid travel arrangements for the same period. The policy also excludes cover for loss of enjoyment.

When submitting your claim you will need to provide written confirmation from the travel arrangements provider (transport, accommodation or tour provider etc.) indicating the prepaid arrangement that has been affected along with itemised receipts and advice of the non-refundable unused component.

You must take all reasonable steps to minimise your claim.

FOR CUSTOMERS TRAVELLING ON OR AFTER THE 28th of FEBRUARY 2011

If you are travelling to Egypt after this date and you believe that you may have to cancel or amend this part of your journey, please contact our office directly on 0800 500 225 so that our staff can assess your case on an individual basis.

IMPORTANT – GENERAL ADVICE

This information must be read in conjunction with the Travelsure Policy Wording as certain restrictions apply.

All Travelsure policies exclude claims arising as a result of war, invasion, act of foreign enemy, hostilities (whether war be declared or not), civil war, rebellion, revolution, insurrection or military or usurped power.
